

## THE LAMPARD INQUIRY

#### **RESTRICTION ORDER**

# PURSUANT TO SECTION 19 OF THE INQUIRIES ACT 2005 Restriction Order No.16 ( "W4")

The Chair has the power under Section 19 of the Inquiries Act 2005 ("the Act") to make orders restricting disclosure or publication of evidence or documents given, produced or provided to the Lampard Inquiry. The Chair will exercise this power in accordance with the Inquiry's Protocol on Restriction Orders, Redaction, Anonymity and Special Measures, which can be found on the Inquiry website.

Any breach, or threat to breach, such an order can be certified to the High Court under Section 36 of the Act and may be punishable by a fine or imprisonment.

### <u>Background</u>

A Restriction Order application has been received from a Core Participant to the Inquiry ("the Applicant"). The Applicant wishes to restrict the disclosure/publication of their deceased relative's ("the Deceased") name. The application is advanced on the basis that the restriction sought is necessary to reduce the risk of harm to members of the Deceased's family. In considering this application, the Chair has had regard for the factors set out in Section 19(4) of the Act and the Applicant's specific circumstances. Having done so, she has concluded as follows:

- 1. There is nothing to suggest that imposing the restrictions sought would in any way inhibit the allaying of public concern.
- 2. There is a risk of psychological harm to members of the Deceased's family that could be avoided or reduced by the restriction.
- 3. Not imposing the restriction is likely to impair the effectiveness of the Inquiry because the Applicant may be unwilling to volunteer information without the benefit of the restriction sought.



The Chair is therefore satisfied that granting the restriction is conducive to the Inquiry fulfilling its Terms of Reference and is necessary in the public interest.

## Individual Restriction Order

In exercise of the power under Section 19 of the Act, IT IS ORDERED THAT:

- 1. The Deceased's name shall not be disclosed or published, unless express permission is given by the Chair, or the Solicitor to the Inquiry acting on her behalf, in writing.
- 2. The Deceased must only be referred to, whether in writing or orally, as "W4". This will be inserted in place of their name in all statements and evidence for the purposes of the Inquiry.
- 3. This Order remains in force for the duration of the Inquiry and at all times thereafter, unless otherwise ordered.
- 4. The Chair may vary or revoke this Order by making a further order during the course of the Inquiry.
