



THE LAMPARD INQUIRY

RESTRICTION ORDER

PURSUANT TO SECTION 19 OF THE INQUIRIES ACT 2005

Restriction Order No.29 (List of Illustrative Cases)

The Chair has the power under Section 19 of the Inquiries Act 2005 ("the Act") to make orders restricting disclosure or publication of evidence or documents given, produced or provided to the Lampard Inquiry. The Chair exercises this power in accordance with the Inquiry's Protocol on Restriction Orders, Redaction, Anonymity and Special Measures, which can be found on the Inquiry website.

This Order is made in accordance with the approach set out in the Chair's Statement of Approach on Redaction, Data Protection and Privacy and is made of the Chair's own volition.

Any breach, or threat to breach, such an order can be certified under Section 36 of the Act to the High Court, which may deal with it as though the breach occurred in proceedings before it and may be punishable by a fine or imprisonment.

ORDER

Pursuant to Section 19(3)(a) and (3)(b) of the Act, IT IS ORDERED THAT:

1. Non-Disclosure of the List of Illustrative Cases

Unless express written permission is granted by the Chair of the Inquiry, or the Solicitor to the Inquiry acting on her behalf, the information disclosed by the Inquiry to legally represented Core Participants on 11 February 2026 and to non-legally represented Core Participants or witnesses on a date thereafter ("**List of Illustrative Cases**") shall not be disclosed, shared or disseminated in any form unless and until the names of the individuals set out in the List of Illustrative Cases are published by the Inquiry on the Inquiry's website. This includes initials, dates of death and the fact of their inclusion in the List of Illustrative Cases, whether orally, in writing, electronically, or by another means, unless and until such information is formally published by the Inquiry on its website.

2. Application to Future Materials

The restriction in paragraph 1 will apply equally to any subsequent versions, updates or iterations of the List of Illustrative Cases.

3. Protection of Redacted Information

Any redacted information within the List of Illustrative Cases or any subsequent version shall remain redacted unless and until the Chair of the Inquiry, or the Solicitor to the Inquiry acting on her behalf, determines otherwise.

4. Parties Subject to this Order

This order applies to the organisations and individuals to whom the List of Illustrative Cases is being provided, including their Recognised Legal Representatives, and to all those who have signed the Inquiry's confidentiality undertaking.

5. Duration of the Order

This Order shall remain in force for the duration of the Inquiry unless varied or revoked by further Order of the Chair.

6. Variation or Revocation:

The Chair may vary or revoke this Order at any time by issuing a further order during the course of the Inquiry.
